
UNIST Graduate Program Readmission Application for 2024 Spring(1st) semester

We are pleased to announce the readmission guidelines for the 2024 Spring(1st) semester as follows;

- 1. Applicability: Graduate(Master's, Doctoral, Combined) Students who dropped out or were expelled.
 - A student shall be readmitted <u>after two semesters</u>, which includes the semester during which the withdrawal(drop out) or expulsion occurred.
 - Readmission application should be applied within 3 years from the date of dropout or expulsion with the following exceptions.
 - The period of military service and treatment for diseases requiring long-term care shall not be included in the possible application period of readmission.
 - According to the addendum of the Guidelines on the Readmissions, the graduate program readmission from 2024-1st semester and 2026-2nd semester shall be recruited without the restriction of submitting readmission application within 3 years from the date of drop out of expulsion.
- 2. Students who are not eligible for readmission.
 - Those who have exceeded the academic period(enrollment duration).
 - Those who were expelled due to disciplinary action.
 - Those expelled after receiving three academic warnings (applicable to the students admitted from the 2014 academic year).
- 3. Readmission Application Period
 - Students submission period : ~ January 2nd(Tue), 2024.
 - * Please Before the relevant Committee schedule for each semester.
 - * Submit to the affiliated Academic & Student Affairs Team of the College
 - Since readmission for graduate program was newly launched after promulgation of the new graduate program readmission guideline during December, application submission date for graduate program readmission for 2024-1st semester is scheduled separately from undergraduate readmission period. However, undergraduate and graduate program readmission process is expected to be scheduled in the same dates from 2024-2nd semester.
- 4. Application Procedure : Submit the application to the Academic and Student Affairs Team of the affiliated College with academic advisor's opinion and an approval of department(school) head
- 5. Required Documents for Readmission <refer to the attachment>
 - 1 copy of the "Request for readmission"
 - The study plan

· Opinion of academic advisor(of department head if needed) on readmission

- 1 copy of the "Notice of collection and use of personal information"
- 1 copy of the academic transcript.

- 7. Important Notes
 - Previous academic records(degree program, affiliated department, type of scholarship, enrolled semester, the number of enrollment semester left, GPA and others) earned will be automatically recognized without any additional procedure.
 - Requirements for graduation and affiliated department for readmitted students will be as follows; However, when the case of following transitional measures cannot be applied arises, decision making from department(school) committee shall be needed.
 - Students entered equal to or before 2020 Fall(2nd) semester: Transitional measures in change of department curriculum will be applied.
 - Students entered after 2021 Spring(1st) semester: Affiliated department and graduation requirements will be unchanged from the date of initial admission.
 - Those expelled with academic warnings shall be expelled permanently upon receiving another academic warning after readmission.
 - Readmission is only permitted once.
 - Those who do not enroll after readmission are not allowed to apply again.
 - Readmitted students shall not be allowed to take a leave of absence for the first semester after readmittance except for the reasons of illness, pregnancy and childbirth and military service.
 - Readmitted students should pay the readmission fee in addition to the regular tuition fee.
