3. Reasons for Disqualifications

- Under article 33 of the national Civil Service Act regarding the disqualification conditions of the appointment of national civil services, successful candidates who are applicable of the disqualification conditions will be excluded from appointment.
- who failed in physical examination will be excluded from appointment.
- persons whose identity has been identified as a person whose appointment has been canceled due to any false application document will be excluded from appointment.
- who has any reasons for disqualification according to UNIST rules of faculty personnel management.
- if a person is found to have a false appointment and has been found to have submitted any false information, forged application document, or related in

fraudulent employment, the appointment may be canceled as per Article 33 of the Civil service Act.

- f. according to UNIST rules and regulations, if the final candidate has peculiar records of any disqualifying activities such as sex offenses, the appointment may be canceled.

4. Contract Period and Responsibility
